



Tasmanian Minerals and Energy Council's

Membership Categories

Corporate/ Corporate Exploration

This category includes private sector corporate entities operating within Tasmania in the mining, quarrying, mineral processing, exploration and mineral processing areas. For the purposes of membership, each corporate entity may have one or more production sites.

Mine Contractor

This category is for the larger contracting firms which undertake mining work on behalf of mine owners.

Associate

This category includes private sector corporate entities which are not mines, quarries, exploration groups or mineral processors, but which have an interest in minerals and / or the energy industry in Tasmania. It may include consultants, suppliers of goods and services, purchasers of mined or processed materials, energy consumers or any other category which is deemed by the Board to warrant associate membership.

Individual

This category recognises that there will be individuals or very small enterprises who wish to join the Tasmanian Minerals and Energy Council. It is for individuals who are not part of a larger organisation, or for individuals employing not more than two people.
